

Global Pharma Healthcare Issues Voluntary Nationwide Recall of Artificial Eye Ointment
Lubricant Due to Possible Contamination

FOR IMMEDIATE RELEASE –February 24, 2023 – Global Pharma Healthcare is voluntarily recalling Batch No (H29) of their **Artificial Eye Ointment** , distributed by **Delsam Pharma**, to the **consumer** level. .FDA informed that few product is leaking when the cap is opened, FDA recommends this may cause bacterial contamination

Risk Statement:

The Artificial Eye Ointment is suspected to have potential bacterial contamination (Not specified)

Use of contaminated artificial eye ointment can result in the risk of eye infections

To date, Global Pharma Healthcare has not received any reports of adverse events related to this recall.

Artificial Eye Ointment (Mineral Oil 15%,White Petrolatum 83%) Lubricant Eye Ointment, (3.5 grams,1/8 Oz) is used as eye lubricant and to relieve dryness of the eyes. The product is packaged in a aluminum tube and placed in a carton box. Delsam Pharma's NDC 72570-122-35, UPC – 3 72570 12235 3 . It can be identified by the photos provided below. The product was distributed Nationwide in the USA over the Internet.

Global Pharma Healthcare is notifying the Brand Owner/Importer of this product, Delsam Pharma and is requesting that wholesalers, retailers and customers who have the recalled product should stop use.
